SPORTHQ PRIVACY POLICY

Your privacy is critically important to us. At SportHQ, LLC, we have a few fundamental principles:

- We are thoughtful about the personal information we ask you to provide and the personal information that we collect about you through the operation of our sales and services.
- We store personal information for only as long as we have a reason to keep it.
- We aim to make it as simple as possible for you to control what information on our website is shared publicly (or kept private), indexed by search engines, and permanently deleted.
- We aim for full transparency on how we gather, use, and share your personal information.

Below is SportHQ, LLC's privacy policy, which incorporates and clarifies these principles.

Who We Are and What This Policy Covers

SportHQ, LLC is dedicated to providing a premier sports facility and training services. Our sports facility and services are developed to take care of each athlete as they train, practice, and play the sport they love.

This Privacy Policy applies to information that we collect about you when you use:

- Our website https://www.sporthq.org
- Sign-up for classes, training, events, or purchase SportHQ apparel

Throughout this Privacy Policy we will refer to our website and our Point of Sale system collectively as "Services."

Below we explain how we collect, use, and share information about you, along with the choices that you have with respect to that information.

Information We Collect

We only collect information about you if we have a reason to do so. For example, to provide our Services, to communicate with you, or to make our services better. We collect information in three ways: if and when you provide information to us, automatically through operating our services, and from outside sources. Let's go over the information that we collect.

Information You Provide to Us

It's probably no surprise that we collect information that you provide to us. The amount and type of information depends on the context and how we use the information. Here are some examples:

- Basic Account Information: We ask for basic information from you in order to set up your account.
 - For example, we require individuals who sign up for a https://www.sporthq.org account to provide a username and email address, first and last name, phone number, address, and for minor's parent's name, gender, school attended, jersey size, graduation year, school, t-shirt size, team/club name and preferred position.
- Transaction and Billing Information: If you purchase something from us a subscription for training for example you will provide additional personal and payment information that is required to process the transaction and your payment, such as your name, credit card information, and contact information.
- Content Information: Depending on the services you use, you may also provide
 us with information about you in the draft and published content for our website.
 For example, if we, or you as a guest blogger, write a blog post that includes
 biographic information about you, or if you have given a testimonial or review for

- our service, then we will have that information, and so will anyone with access to the Internet, if you choose to publish the post publicly.
- **Communications with Us:** You may also provide us information when you signup for camps, clinics or training or you contact us using our contact form.

Information We Collect Automatically

We also collect some information automatically:

- Log Information: Like most online service providers, we collect information of
 the web browsers and servers. Such as the browser type, IP address, language
 preference, the date and time of access, operating system. We collect log
 information when you use our Services for example, when you visit our
 website, browse the pages or blog.
- Usage Information: We collect information about your usage of our Services. For example, we collect information about the actions perform on our site in other words, who did what, when and to what thing on a site (e.g., Which page you have visited on our site). We also collect information about what happens when you use our Services (e.g., page views, searches, button clicks). We use this information to, for example, provide our Services to you, as well as get insights on how people use our Services, so we can make our Services better.
- Location Information: We may determine the approximate location of your device from your IP address. We collect and use this information to, for example, calculate how many people visit our Services from certain geographic regions.
- Information from Cookies & Other Technologies: A cookie is a string of
 information that a website stores on a visitor's computer, and that the visitor's
 browser provides to the website each time the visitor returns. Pixel tags are small
 blocks of code placed on websites and emails. SportHQ, LLC uses cookies and
 other technologies like pixel tags to help us identify and track visitors, usage, and

access preferences for our Services, as well as track and understand email campaign effectiveness and to deliver targeted ads.

How We Use Information

We use information about you as mentioned above and as follows:

- To provide our services for example, to set up and maintain your account, or charge you for any of our paid services;
- To further develop our services for example by adding new camps, clinics, tournaments, leagues and training that we think our users will enjoy;
- To monitor and analyze trends and better understand how users interact with our services, which helps us improve our Services and make them easier to use;
- To monitor and protect the security of our Services, detect and prevent fraudulent transactions and other illegal activities, fight spam, and protect the rights and property of SportHQ, LLC's facility and others;
- To communicate with you about offers and promotions offered by SportHQ, LLC
 and others we think will be of interest to you, solicit your feedback or keep you up
 to date on SportHQ, LLC's services and our products; and
- To personalize your experience using our services, provide content recommendations and serve relevant advertisements.

Sharing Information

We do not sell our users' private personal information.

We share information about you in the limited circumstances spelled out below and with appropriate safeguards on your privacy:

- Subsidiaries, Employees, and Independent Contractors: We may disclose information about you to our employees. We require our employees to follow this Privacy Policy for personal information that we share with them.
- Third Party Vendors: We may share information about you with third party vendors who need to know information about you in order to provide their services to us. This group includes vendors that help us provide our services to you (like payment providers that process your credit card information) and those that help us understand and enhance our services (like analytics providers). We require vendors to agree to privacy commitments in order to share information with them.
- As Required by Law: We may disclose information about you in response to a subpoena, court order, or other governmental request.

Security

While no online service is 100% secure, we work very hard to protect information about you against unauthorized access, use, alteration, or destruction, and take reasonable measures to do so.

Choices

You have several choices available when it comes to information about you:

- Opt-Out of Electronic Communications: You may opt out of receiving
 promotional messages from us. Just follow the instructions in those messages. If
 you opt out of promotional messages, we may still send you other messages, like
 those about your account and legal notices.
- Set Your Browser to Reject Cookies: You can usually choose to set your browser to remove or reject browser cookies before using SportHQ, LLC's websites, with the drawback that certain features of SportHQ, LLC's website may not function properly without the aid of cookies.

Privacy Policy Changes

Although most changes are likely to be minor, SportHQ LLC, may change its Privacy Policy from time to time. SportHQ, LLC encourages visitors to frequently check this page for any changes to its Privacy Policy. If we make changes, we will notify you by additional notice (such as adding a statement to our homepage or sending you a notification through email). Your continued use of the Services after any change in this Privacy Policy will constitute your consent to such change.
